Your Opportunity

NBMCA's On-site Sewage System program is designed to protect the environment and people's health and safety by regulating and ensuring compliance with Part 8 of the Ontario Building Code (OBC), regarding the installation and maintenance of private on-site sewage systems within designated areas of Nipissing District and the District of Parry Sound. Reporting to the Chief Building Official (CBO), Manager – On-site Sewage System Program, you will be conducting inspection of lands currently serviced or proposed to be serviced by on-site sewage systems to ascertain compliance with the provisions of the Ontario Building Code, Municipal By-laws and other applicable regulations and standards.

Key Responsibilities

- Responsible for the review, verifications and recommendation for approval to the CBO-SS, of all sewage system designs submitted and the inspection thereof, to ensure compliance with Part 8 of the OBC.
- Applications for approval include:
 - Sewage System Applications
 - Planning Applications
 - File Review Applications
 - Other land development proposals

- Responsible for the investigation of sewage system concerns regarding malfunctioning systems or systems that are in contravention of the OBC.
- Work in a professional manner and provide technical support to the public with respect to requirements of Part 8 of the OBC, relevant Municipal By-laws and other applicable legislation.
- Conduct background research on properties and conduct site inspections of existing systems as required by provincial legislation. This includes the Mandatory Maintenance Inspection program, which requires inspections of all on-site sewage systems identified in the North Bay-Mattawa Drinking Water Source Protection program as a significant threat to municipal drinking water sources. The OBC requires that these inspections be conducted every five years.
- Work in compliance with the *Occupational Health and Safety Act*, its regulations and the NBMCA's safety policies.
- Attends building/development, community and other meetings as required.

Required Knowledge, Skills & Abilities

- Proficiency in GIS and mapping tools; ability to interpret ecological data.
- Excellent verbal, and written communication skills for all correspondence.
- Excellent problem solving, conflict resolution, time management, communication, and organization skills.
- Ability to work independently and as part of a team in a fast-paced environment while meeting deadlines.
- Flexible and open-minded, with the ability to adapt to shifting priorities.
- Valid Ontario G-class driver's license required. (Required to be validated annually).

Education & Experience

- Post-secondary education in environmental or engineering technology, or other closely related field.
- Certification as a sewage system inspector for Part 8 of the OBC is an asset. (Willingness and ability to obtain the certifications will also be considered).
- Proficient in Microsoft and ADOBE applications.
- Experience with enforcement, property evaluations, and partnership development is an asset.

Working Conditions

- Combination of office and field work.

- Regularly required to work outdoors in adverse weather and uneven terrain.

Compensation

Salary Range - \$32.03 to \$37.47 per hour, based on a 35-hour work week.

Full-time contract (unionized).
