Following the end of the two-year contract for with MNP after the preparation of the financial statements of the NBMCA for fiscal years 2023 and 2024 the Manger, Finance requested quotes for services based on a new two-year contract plus two additional years from three local accounting firms and MNP (based in Sudbury).

MNP and BDO provided pricing proposals which have been appended to this report and are summarized for pricing below.
